## The Franco-British Finance Summit in Paris



On the 15-16th of March 2013, the Franco-British organised a joint French-UK event comparing the financial sectors of both countries. This event was organised by ESSEC (one of the top business schools in France) and many of the other top universities in France and Great-(including Oxford, Britain Cambridge, LSE, Imperial College and UCL in the UK, Assas, Ecole Polytechnique, Sciences Po, HEC, ESSEC, ENS and the Sorbonne in France).

For this weekend, over 80 students came together for two days of keynote speeches, networking, discussion workshops and evening entertainment. The highlight of the event was a reception in the beautiful Salons of the "Residence de l'Ambassadeur", hosted by H.E. Sir Peter Rickett, Ambassador of Great-Britain and Northern Ireland to France.

Students were addressed by Mr. Pierre Tapie (President of the Conférence des Grandes Ecoles), and Sir Howard Davies (former Director of the LSE and former executive Chairman of the FSA), who gave their views on the financial sectors of France and Great-Britain. Following this, students were involved in one of 6 workshops along with 10-15 other students in which they discussed one of the proposed themes on our website with senior academics, public figures and industry participants. All discussions were held in English.

#### The outcomes of the project

After the conference, a student from each workshop was in charge of writing a short document with the outcome of the group's discussion as well as a policy recommendation when possible. The Student's feedback was very positive and while 85% of students said that the event met or exceeded their expectations, students very much appreciated the quality of the workshops and speakers as well as the more prestigious events such as the afternoon at the Ambassador's Residence.

In order to successfully lead this event, a number of sponsors have helped us and deserve a special mention: ESSEC Business School, The British Embassy in Paris, The Institut Francais in the UK and Allianz Kulturstiftung, without whom this event would not have been possible.



#### A number of different issues

The finance Summit took place over two days and students tackled a number of different issues such as the potential effects of tax harmonization, the benefits of happiness indices versus financial indices to evaluate a country's performance or the impact of the Euro on French and British Financial Sectors.

# The Comparative Conference in London

On the 14th January, the Franco-British Connections had the pleasure of hosting their first event of 2013 in Goodenough College. The event, entitled 'The Communication of Social and Scientific Research in France and the UK', gave an insight on how research is transmitted from an academic setting to the general and it was a great public, opportunity for students to explore and analyse the ways in which these methods communication vary between the cross-channel neighbours, namely France and the UK.

The first speaker was Professor Bloch, who researches anthropology at the London School of Economics and the Ecole Normale Supérieure. Prof. Bloch brought up outlined the particular relationship between social science research and the wider public in France, amongst others thanks to the French Education system, which is geared and inclined towards philosophy; but also due to the presence of an important community, intellectual French ranging from politicians to members of the press, which makes it more inclusive and relevant to the population.

Next was Professor Valls-Gabaud, who used to be the deputy director at the Observatoire de Paris, and now continues to pursue his astronomy research interests there.. Professor Valls-Gabaud gave a very extensive overview of the communication of science, more precisely astronomy, in France. He also put forward some ideas for improvement, mainly directed at improving the science learning experience for children.

Lastly, Professor Lord Winston professor at the Imperial College School of Medicine, and presenter of several successful and award BBC documentaries winning explained his views on the communication of science from a medical and political point of view, and again highlighted several areas of improvement in the domain of education.

This debate, which is currently of major concern in Europe, was punctuated by topics such as the Neighborhood policy, renewable energies and democratic considerations.



The square debates deal with European Political Issues and aim to trigger students at an intellectual level. They compete on an ideological as well as rhetorical level.

## **Future Events**

There are several events that are due to take place in the coming year and that are promising to be as successful as the ones in 2012-2013.
